Goodbye District 1

- Supervisor Kevin Jeffries addressed the community to formally conduct the transition of the Temescal Valley from District 1 to District 2.
- He expressed the real honor of representing the Temescal Valley for the past 10 years.
- Supervisor Jeffries recapped the growth of Riverside County, 600,000 population in the early 70's currently 2,550,000 in 2022. 4th largest county in California by population, 1oth largest in the entire United States.

- 24-year veteran of the CHP
- The Riverside Station covers traffic issues in the Temescal Valley
- Captain Miller provided 2022 statistics Temescal Valley:
 - 50 DUI Arrests

- 400 Citations (speeding, stop sign violations, unlicensed, suspended drivers, crashes, traffic collisions
- Control traffic at 54 schools
- Issues raised my Board Members and audience:
 - Illegal stopping and parking in posted areas
 - Running of red lights
 - Speeding
 - Traffic control or E-Bikes
 - Heavy traffic pre-planning preparations for Super Poppy Bloom

3.4 Riverside County Fire

- Battalion Chief Jason Allan provided report
- Average response time 6.5 minutes
- Statistics for December 2022

- False Alarms	13

- After the rains, this year fire prevention will be a major concern moving into the upcoming fire season
- Sandbags and sand are available
- Last year Station 64 had 1925 calls outs, of which 1463 were medical

3.5 Riverside County Sheriff

- Captain Kevin Lamb presented
- Announced that he will be the Captain at the new Lake Matthews Sheriff Station located at Temescal Canyon Rd and Tom Barnes, just north of Cajalco.
- Lake Mathews Station is scheduled to open late 1st quarter 2023
- It will serve an area of approximately 100,000 residents in unincorporated communities of Home Gardens, Coronita, Lake Hills, Woodcrest, El Cerrito, Temescal Valley, Lake Mathews and Gavilan Hills
- Fully staffed there will be 65 personnel assigned to the Station

- Informed the Board can Audience that there would be a new Enforcement Officer assigned to the Temescal Valley
- Jamison reported that the area off of Bedford Motorway that is adjacent to The Retreat has an increased level of focus and that there should be improvements in the situation forthcoming
- The abandoned house that was occupied by squatters is being addressed,
