# 3) Community Updates

# 3.1 Congressman Calvert Staff Update

- Jett Benavidez provided update

- Indicated that there are several handouts available at the back table for those interested.

- Voted for HR 2811 "Limit, Save, Grow Act of 2023" Increases the federal debt limit and decreases spending. It also repeals several energy tax credits, modifies the permitting process and other requirements for energy projects, expands work requirements for the Supplemental Nutrition Assistance Program (SNAP) and other programs, and nullifies regulations for the cancellation of federal student loan debt.

- Introduced HR 3041, to protect homeowners from higher unfair fees on their mortgages.

- Will attend the June 2<sup>nd</sup> Bicentennial Ribbon repainting ribbon cutting at the Prado Dam.

# 3. 2 Senator Kelly Seyarto SD 32

- Braxton Difuntorum provided update
- SB 86, approved by the Senate and moved to the House
- SB 259, passed Public Safety, addresses Fentanyl issues.

- SB 221, would provide tax credits to individuals and provide housing market rates to nonprofits and other associations. This bill has a repeal provision that would continue the intergenerational transfer of the original property tax value. Protects descendants from being forced to pay property taxes on the current market value.

SB 342, addresses teaching financial literacy in Public Education

- There was a general discussion on areas that need targeted enforcement
  - Parking situation on Temescal Canyon Road at 15 Freeway
  - Knabe Rd, speeding and failure to stop issues

- Public expressed appreciation for the traffic control during the Poppy season.

- Priscilla Galvan Emergency Services Coordinator (ESC)

- Adrian Cardenas Emergency Services Coordinator (ESC)

- EMD is working on the Temescal Valley local mitigation plan and is

continuing to seek input on prioritizing local hazard concerns.

- Poppy monitoring and support of other departments has ended due to no more poppies

- Provide brief overview of the meeting on possible Robertson vesting of mining rights on the east of the 15 Freeway.

- Processing on the initiative was delayed due to concerns raised regarding Native American Tribal concerns that need to be addressed.

- Indicated that there are mobile spay and neuter clinics

#### 4) New Business

#### 4.1 CalTrans Update

- Carolina Rojas, Public Information Officer Construction

- Thomas Ainsworth, Chief TMS Support

- Haissam Yahya, P.E., Office Chief

- Ms. Rojas announced that the 15 Freeway Slab replacement project has been completed, this project was from Eastvale to SR 60.

- Ms. Rojas also indicated that CalTrans has a website to enter customer service requests "**csr.dot.ca.gov**", You can report anything from landscaping, potholes, uneven pavement, ramp signal issues, etc.

- Mr. Yahya, Division Chief of Safety, recapped the budgeted \$22,000,000 for inspections. He covered a wide variety of projects from freeway culverts to the Toll Expressway extension south to SR 74

- General review of ramp metering based on measure freeway traffic loads

- Question was raised on reversible lanes that would allow for time-of-day use. Answer was that they are expensive and take up a lot of real estate and are therefore, usually not a practical solution. - Question raised regarding the amount of continued development without building the supporting infrastructure first. The answer was that the infrastructure historically always follows development in a region.

The lengthy and general topics of conversation covered concerns regarding traffic congestion, length of time to engineer projects and produce the required EIR justification that adds years to the project and raises the cost.

- Question raised regarding possible emergency turnarounds be added in the 15 Frwy Toll Lane extension to SR74 to the center median. Turnarounds are spec'd when exits are 5 miles or greater apart.

- Comment raised from floor regarding on-ramp signals not always working

## 4.2 Mac Board Nominations

- The positions of Chair, Vice Chair and Secretary need to be filled.

- Nominations were requested

- Eric Werner, the longest serving member of the Temescal Valley Municipal Advisory Council recommended following the established practice of rotation where Chair would rotate out and Vice Chair and Secretary would move up into the next position.
