3.2 Senator Seyarto (SD 32) Staff Update

- Braxton Difuntorum provided the update
- SB19: Establishes upon appropriation by the Legislature, the Anti-Fentanyl Abuse Task Force. Amended and passed, re-referred to the Committee on Public Safety with recommendation: to Consent Calendar
- SB 86: Requires the state to maintain a website that enumerates the rights of victims and directs them to statewide and local resources moved from the Senate to the Assembly
- SB 259: This bill establishes that any budget report provided by a state agency to the legislature will be required to also be posted on the agency's website
- SB 342, addresses teaching financial literacy in Public Education
- Senator Seyarto selects Friends of Leaps & Bounds Pediatric Therapy as the 32nd District Nonprofit of the Year for 2023
- Veterans Expo November 2nd, 10AM-2PM, Murrieta

- Assembly bill 595 now is identified as AB 491. This bill would require all animal shelters, to provide public notice on their internet website at least 72 hours before euthanizing any animal.

- Following up on a report of a child scream and the finding of a bike at an odd spot, led to a search which did not produce a child in distress. It is assumed that a child crashed a bike and went home after the bike crash.

- There was no specific pocket area of criminal activity
- There will be increased coverage resources (people) during the 4th of July. It is expected that there will be thousands of calls for service that night. Dispatch will be inundated with calls for service.

3.5 Riverside County/CAL Fire Representatives

- Battalion Chief Jason Allan provided the update
- Last month there were 85 calls. Fourteen (14) of those calls were traffic collisions.
- Starting to have some little grass fires
- Fire staff will be working with law enforcement on the Fourth of July. It is expected that our dispatch center will be overwhelmed
- The wet weather has increased the amount of grass in the area, so creating defensible space is necessary
- Offered condolences to the Riverside County Sheriff's Department for all their losses
- There may be a controlled burn weather permitting in the Lake Mathews area

3.6 Code Enforcement

- Code Enforcement Officers will be working with law enforcement during the 4th of July
- Warrants were served at the motorway property. Dealt with the owner and made progress in compliance. Major improvement has been made on the property.

- Discuss emergency preparedness to lessen the impact of a local disaster e.g. earthquake, wildfire
- If the fire department or law enforcement issues evacuation orders, be prepared to evacuate

3.10 Elsinore Valley Municipal Water District

- Jack Ferguson provided the update
- The Elsinore Valley Municipal Water District will have a new water logo
- The EVMWD website improvements will make it easier to use
- EVMWD costs are increasing
- Hiring people due to EVMWD area expansion
- The estimated date of completion for the treatment facility is April

3.12 Supervisor Karen Spiegel's Office

- Melania Castellanos Supervisor Spiegel's Field Representative provided the update
- After receiving input from all departments, a recommended budget prepared by the Executive Office, including any adjustment, by the Board is scheduled to be adopted on June 7th.
- Supervisor is setting aside about \$300,000 for road traffic, lighting and sidewalk improvements in the unincorporated areas of District 2
- Office received resident input for a project on the intersection of Glen Eden Road and De Palma Road which is a safety hazard
- Discussed Animal Services regarding vaccines, deworming treatment, and micro chipping
- Appointment of Fred Myer to the Flood Control Commission, District 2
- Appointment of Julie Showalter to the Temescal Valley MAC

4.1 Southern California Edison

- The Alberhill substation project which has been on the books since 2009 is still under review. Over the years project alternatives have been studied including battery storage, solar, etc. A third project is possible.
- On June 15, 2023 conducting community meeting on Public Safety Power Shutoff protocol and how to prepare for an emergency

4.2 El Sobrante Landfill Update

- Art Marquez & David Meyer
- El Sobrante Landfill tours are available to community members to learn more about the landfill
- The El Sobrante Landfill activities include summer day camps, calendar art contests, seasonal community events, community cleanups
- Work is currently in Cell 13. We try to be as invisible as possible in our activities. We are in operation 24 hours a day six days a week. Currently 60 individuals work at the landfill. The landfill is averaging about 11,000 to 12,000 tons of trash per day. In the process of hiring a new community relations individual to help with landfill community activities. The landfill has an odor neutralizer system running to control odors. The methane gases are collected.
- Waste that is identified as producing significant odors is buried as quickly as possible
- When a community odor complaint occurs the community relations representative will come out to the community to address the issue
- Community comments regarding El Sobrante Landfill activities include: 1) every night experiencing odors; 2) filed approximately 50 odor complaints to AQMD; 3) reselling gas back to the gas company; 4) the landfill smell is worse over the last

two to three months; 5) the odor smells like garbage; 6) come to Terramor at 6:30 AM to evaluate the odor; 7) the cost of odor mitigation maybe limiting your odor elimination activities.

- Contact the El Sobrante Landfill first with all concerns about odors
- Terramor homeowners to tour the El Sobrante Landfill facility to gain a better understanding of its operations

4.3 MAC Board Elections

- The Board consensus was that the Bob Hafner (Vice Chair) should become the Chair and the Lee Wilson (Secretary) should become the Vice Chair. Jerry Sincich was elected to the Secretary position

4.4 MAC Board Time Change Discussion

 A new 6:30 PM TVMAC meeting start time was established, in an effort to balance the need to increase community participation in TVMAC meetings and the availability of State staff, County staff and local individuals and organizations providing community updates/information
