3.1 Congressman Calvert Staff Update

3.2 Senator Seyarto (SD 32) Staff Update

- Braxton Difuntorum provided the update
- SB19: Establishes upon appropriation by the Legislature, the Anti-Fentanyl Abuse Task Force. September 14th Assembly amendments concurred in. September 21st enrolled and presented to the Governor.
- SB67: Requires coroners and medical examiners to report actual or suspected overdoses to the Emergency Medical Services Agency (EMSA), which is then required to submit this data to the Overdose Detection Mapping Application Program (ODMAP). September 13th Assembly amendments concurred in. September 20th enrolled and presented to the Governor.
- SB82: Requires a county assessor to accept an electronically generated letter of service-connected disability in lieu of an original letter, as specified. September 11th Assembly amendments concurred in. September 15th enrolled and presented to the Governor.
- SB86: This bill requires the statewide victim resource center to maintain a website that includes information about victim resources and the criminal justice process, July 11th presented to the Governor. July 12th approved by Governor and Chaptered by Secretary of State,
- SB259: This bill establishes that any budget report provided by a state agency to the legislature will be required to also be posted on the agency's website. Signed by the governor and chaptered by the Secretary of State on September 1st.
- SB520: Clarifies that a qualified taxpayer may continue to claim the homeowners' property tax exemption if the taxpayer is not occupying their home because they are confined to a hospital or other care facility. September 14th Assembly amendments concurred in. September 21st enrolled and presented to the Governor.
- SB602: This bill extends the operative timeframe for trespass letters of authorization from 30 days to 12 months, as specified. September 7th Assembly amendments concurred in. September 13th enrolled and presented to the Governor. October 7th approved, Chaptered.

- Lt. Steve Favero provided the update
- The crime stats for the month of September. The Sheriff Department responded to 357 calls for service which was an increase of 13 calls for service from August.

3.5 Riverside County/CAL Fire Representatives

- Captain Joe Reilly provided the update
- There were 164 calls for service in September at Station 64.
 - Traffic collisions 13
 - Standby 2
 - Rescue 1
 - False Alarm 8
 - Public Service Assist 18
 - Medical 120
- Average response time was 5.8 minutes. 72 calls were less than five minutes and 65 calls were just over five minutes.
- There was a prescribed burn in the Lake Mathews area

3.6 Code Enforcement

- Jamison Cole provided the update
- The Temescal Valley area will now be covered by the Lakeland Village office to provide more direct Code Enforcement service to the area
- Introduced Shane Hidey, the Code Enforcement Officer, who will now cover the Temescal Valley
- The Short Term Rental team is up and running to enforce the County Short Term Rental Ordinance

3.7 California Highway Patrol

- Captain Steven Branconier provided the update
- In memory of Sgt. Steve Licon, a freeway sign dedication ceremony took place on October 11, 2023. Freeway signs were placed on the northbound and southbound sides of the freeway. An estimated 400 people participated in the freeway sign dedication ceremony.
- Working with Supervisors office on bicycle and parking issues in Horsethief Canyon Ranch
- We do not have the resource to enforce parking 24/7

3.8 Riverside County Emergency Management Department

- Adrian Cardenas provided the update
- Working on next years CERT courses and want to get some CERT classes in the Temescal Valley
- The MOU for the placement of the Temescal Valley CERT trailer at the Temescal Valley Water District site is expected to go to the Board this month

3.9 Temescal Valley Water District

- Jeff Pape provided the update
- A new second tank at the Wildrose reservoir site was approved. The tank will provide 2.8 million gallons of water storage in the Temescal Valley. The tank cost is almost \$6.0 million dollars.
- In the middle stages of picking a vendor and a system for automatic meter reading. This project cost is in the \$3 to \$4 Million dollar range. We will be picking a vendor this winter. Through spring and into summer we'll be doing the changeover.
- Added capacity to the treatment plant and allocated funds going forward to sludge management
- In the community we are converting some potable water meters to recycled water meters

3.10 Elsinore Valley Municipal Water District

- Jack Ferguson provided the update
- Today the EVWMD celebrated the groundbreaking ceremony that signals the start of a transformative \$250 million expansion of the Regional Water Reclamation Facility. This is a significant commitment to meet the growing demand for water and wastewater resources.
- The EVMWD sewage rate will increase an average of \$5.00 for a family of four

4.0 New Business

4.1 Western Riverside Council of Governments Update (WRCOG)

- Chris Gray, WRCOG Deputy Executive Director
- We are a joint powers authority, which means we focus on programs and projects that help our members. The WRCOG members include 18 Western Riverside Cities, 4 Riverside County Supervisors, 2 Water Districts, and the Riverside County School District. We have two main focuses, helping our members get money and meet all the federal and state mandates. We have programs in environmental energy and transportation.
- Over the past 20 years, WRCOG has collected a billion dollars in TUMP fees which has been given to members. WRCOG funds have helped fund the Indian Truck Trail and Cajalco interchange projects.
- Over the next five years WRCOG will be giving out approximately \$250 million in funding. WRCOG funds will be going to widening the Temescal Canyon Road and I-15 Freeway.
- People moving from LA County, Orange County and San Diego County to Riverside County are contributing to the County population growth
- WRCOG is divided into 5 differ zones. Temescal Valley is split between two WRCOG zones.

- The team looks through and assesses Cold Case Homicide evidence for successful prosecution or arrest. Assist the Riverside County Coroner's office in identifying persons and missing persons.
- Now able to identify individuals with DNA
- Grants from the federal government are helping with getting cases going sooner
- Working on cases in the 70's and 80's. Currently sorting through 600 cases.
