Approval of Minutes The minutes from the last meeting on March 24 were approved.

Reports:

a) Riverside County Fire – not present

b) Riverside Sheriff – Deputy Tran gave a briefing on the status of things on Lakeland Village including the emphasis on Perret Park. Gave credit to Code Enforcement in the continued effort toward cleaning up the homeless encampments.

c) Riverside County Transportation Land Management/Code Enforcement - Jamison Cole gave an update on the homeless encampments in Lakeland Village and the progress made. Made mention of the increased fines for fireworks violations. Fielded questions from the audience.

d) Senator Melissa Melendez's staff – SB 238/249 anti-discrimination bills failed. Senator Melendez is sponsoring military care packages. She is holding a Town Hall on June 18.

f) California Highway Patrol – Captain Penner from Temecula office of CHP gave an update from the CHP, there have been 3 fatal accidents on the Ortega Highway. CHP is responsible for abandoned vehicles in the area and should be reported.

a) PAR 200023 AAA Pallet

Howard Hardin gave an update on the project at Grand/Turner to produce refurbished recycled pallets. Will require 7 trucks making 3 trips per day. Currently located in Perris moving to Lakeland Village. Will provide needed turn lane and extensive landscaping.

b) CUP 3776 Bahia Village Communities – Dean DeLisle

55+ community at Grand/Palomar, will be completely solar powered and have 71 units in 4 different models with swimming pool, dog park, clubhouse and many other amenities.
