5. **New Business:**

a) Unincorporated Communities Initiative & Redistricting- Jason Farin (Riverside County Executive Office)

Jason Farin gave a Redistricting Briefing and accompanying PowerPoint deck outlining the process for redistricting, with a background on state laws, county framework and a list of the key milestones and next steps. He encouraged everyone to go online and complete the Unincorporated Community

Initiative (UCI) Survey. Future milestones will redistricting boundaries that will be approved by the Board of Supervisors.

b) Elsinore Valley Municipal Water District – Bonnie Woodrome (EVMWD)
Gave an update on current EVMWD issues.

A presentation was given for the Rome Hill Commercial project (which is actually located in Lake Elsinore city limits but bordered by Lakeland Village). Present was Guy Selleck-President of BuildersMax, Michael Carrol-Project Manager and Jorge Rivera-Architect

They gave a brief rundown on the project that will be located on Grand Ave (across from Golden Office Trailers). Will house 100,000+ Square feet of space, plus ample parking for commercial businesses.
