SUPERVISOR KEVIN JEFFRIES FIRST DISTRICT UPDATE Lakeland Village 5/25/22

Riverside County Sheriff: Riverside County Sheriff is in the process of creating a “sub-station” for a Deputy on the same property as our Community Center to be more visible in the community. This office space will be in Building D (same building that District 1 – Kevin Jeffries, Animal Control, and Code Enforcement currently use) 16275 Lake Elsinore, CA 92530.

Community Center Voting Station: The Lakeland Village Community Center is a voting location. Current drop off hours are Mon – Fri 10am – 3pm until early voting begins. Early Voting is June 4 - 6, at this time, you can vote/drop off your ballot between 9am – 5pm. On election day the community center polling location is open 7am - 8pm. Voted ballots must be received by the election officials no later than the close of the Vote Centers on Election Day or be postmarked on or before June 7, 2022, and received no later than seven days after Election Day to be counted.

Should We Move Forward With A Community Vote?: In response to resident requests to explore options to improve community services and/or infrastructure, a presentation was made by the County in 2018 for options to help fund improvements, potentially including items such as Grand Ave. street lights, sidewalks, crosswalks with flashing lights, Grand Ave. widening or curb & gutters, Community Center, Code Enforcement, and enhanced Sheriff Patrol funding. (CHP reports Grand Ave. is one of their most deadly unincorporated roads). In 2019/20 the County kicked off an Unincorporated Communities Initiative (UCI) needs survey, which confirmed the support of local residents for these improvements. If put on the ballot, Lakeland Village can decide if they want to proceed with a small annual parcel tax of \$29 a year.

Infrastructure improvements: The First District office is pursuing grant and funding to help fund local improvements:

- 1. Maiden Lane Flood Channel:** Project awarded, construction starting later this year.
- 2. Perret Park:** Rainwater run-off down Blackwell Blvd. always washes out the beach. The Project will help the water going straight so that the actual public beach sand is not washed away.
- 3. Grand Ave. Improvements:** We are looking to start adding curbs and sidewalks starting near Adelfa St. and proceeding southerly towards Turner St. (Challenges: Limited funding and right-of-way issues)
- 4. Next Dirt Road Paving:** Gamel Road, Zinck Way, Lower Landerville, Crawford and Custer Street.
