1. No selection yet for NW Division Chief
  2. 107 calls last month; 79% medical/traffic accident responses
  3. Response time average 5.1 minutes (depends upon dispatch information)
  4. Reminded folks to change batteries for smoke detectors
  5. Nov. 10 “Spark of Love” toy drive program
  6. “Burn Ban” still in force due to drought; fire permits still required
