- A. CHP Officer Overture:
  - 1. Focusing on off road vehicles (Horsethief and DePalma). Impound vehicles minors riding.
  - 2. Motorcycle Joy ride in Ontario California crack down. (Dispersed vehicles)
  - 3. Mead Valley riding off road vehicles.
  - 4. Lee asked the officer on checking on the traffic at I-15 and Temescal Canyon road on parking traffic (Reminded on the 6 fatalities we have had over the last 5 years).

- C. CAL/Fire Update Captain Kevin Malloy
  - 1. 185 calls for service (December only)
  - 2. 7.1-minute response time. (December only)
  - 3. 2020 had 1822 calls for service.
  - 4. 2020 6.6 minutes response time for call to service for the entire year.
  - 5. 81% calls are medical. This averages 5 calls a day. 151 calls a month. This is an increase of 6.5% from last year. This has increased over 30% in medical calls over the last 5 years.
  - 6. Toy drive had 968 toys. One organization to where toys went through. They filled six trucks.
  - 7. Fire Station is closed to the public.
  - 8. Glen are asking info for home hardening. They have been doing defensible space inspections and training.
  - 9. Santa was available to go through Sycamore Creek.
  - 10. Jeff Borough from fire department and Jeff Bryant introduced themselves.

- G. Riverside County Planning Reginal Housing Needs Robert Flores:

  - 3. Need to have 17,000 low income and 23,000 for moderate/above moderate (41%/58%). This is only for the unincorporated part of the county.
  - 4. One area identified was in the Home Garden area. This gave 530 units.

  - 6. Update our guidelines and elements by October 2021.
  - 7. Planning commission workshop in Feb. 2021.
