Riverside had the Great Flood of 1945

The flood district is broken into 7 districts. Two natural flood areas are Cajalco Creek and Mockingbird Canyon.

Problem is when property is developed there is a need to reduce and mitigate the flow of water.

Flood control has several programs: one is "Only Rain Down the Storm Drain".

Low Impact Development, Water Conservation Road affiliation Demonstration Testing Facility which has Bio-retention, Porous Asphalt, Monitoring Station, Porous Concrete, Permeable Pavers System,

Mockingbird Wash flood area, sediment accumulates at Mockingbird Reservoir. There was sufficient damage and repairs to district levies system at Mockingbird Canyon Road after storm. Need to prevent residents from converting driveways crossing which disturb the flow of the Mockingbird Canyon Wash. The driveways that are created do not allow for sufficient water passage under and they get washed out with the flow of water.

Need to acquisition the flood plain area because the property owners have right of way. A culvert 36" pipe is not wide enough to handle the flood waters.

Need to maintain a certain grade which will slow down the flow of water.
